The subscription period starts in the month following the receipt of the payment. Retroactive orders are not accepted. Please apply the following procedure for ordering and payment:

1. Send us your order either by fax or by letter (state your e-mail address in the order) or by e-mail. A complete precise address is very important for correct delivery of the journal.
2. Waesseri will send you an invoice (as a PDF file) by e-mail.
3. You then make the payment. Follow the instructions in the section "Payment".
4. Only after receipt of the correct payment will Waesseri start delivery of the journal to the address stated in your order.
